

DROP SHIP PROGRAM GUIDELINES

We drop ship! We charge you \$2 per address shipped per order in addition to our wholesale price and shipping charges. Here are our guidelines:

- 1. Fax or e-mail your individual drop ship order to us. Be sure to specify style, quantity, your customer's name and address. Tell us where you want a delivery confirmation number e-mailed and tell us how you want to pay for the item(s). We normally ship via post but can accommodate FedEx 2 Business Day and Overnight orders using our account. We can not use third party billing.**
- 2. We will send you a reply either by fax or e-mail confirming that your order shipped and what we charged you – you will also be sent an invoice in the mail. It is your responsibility to confirm order placement, shipment and delivery to your customer.**
- 3. We suggest that you keep a small inventory of our items as we do sell out and we do not wish to disappoint your customers.**
- 4. You must accept our drop ship terms and conditions by printing, signing and then faxing us your acceptance.**
- 5. Pay Pal, or other similar online payment service, is not available for use with our drop ship program due to their shipping policies.**
- 6. You can not cancel a drop ship order if it has been shipped.**
- 7. If you are using images from our website to promote our products, please sign and return to us our Image Release Form.**
- 8. All other Purchase Order Terms and Conditions apply.**
